# Migrants? Refugees?

---

In the Cold War context—for the West, refugees like Vietnamese boat people, Romanians, Czechoslovakians, all viewed as victims of **communism**, able to make a claim (at that time politically acceptable) to enter and settle, on humanitarian grounds, not because of economic or labour needs of the host country. They became migrant workers in any case.

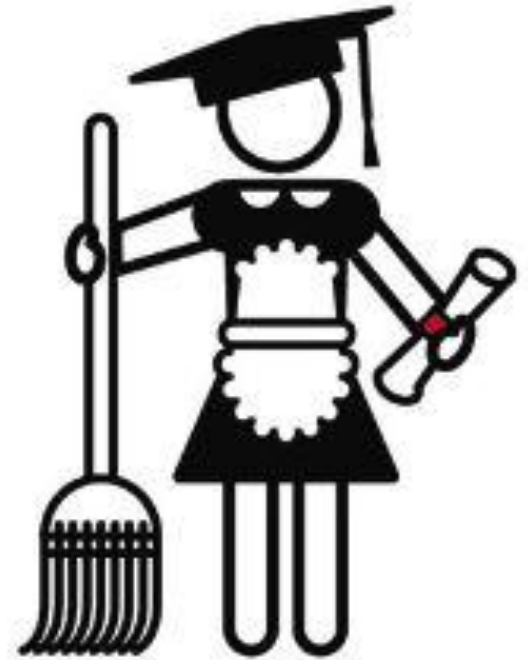

# Labour Migrants inside EU

---

“Europe has built a fortress around itself to protect itself from ‘illegal’ immigration from the South” (1)

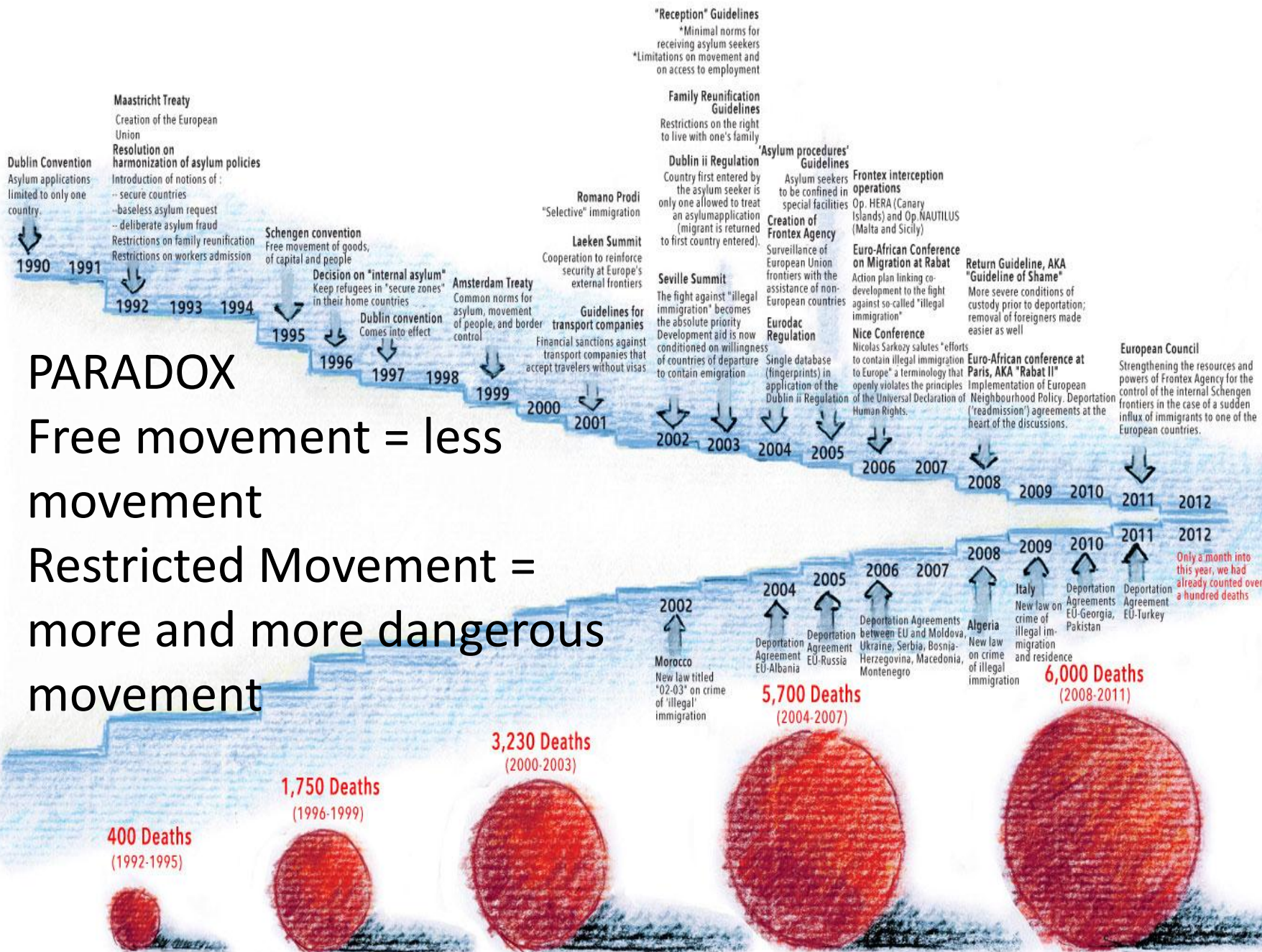
And for migrants inside the Fortress – 2 aspects:

- - PARADOX OF FREE MOVEMENT pressure to move when it is not allowed; once it is allowed, pressure reduced since migrants can COME AND GO (esp. in Schengen)
- - new forms of xenophobia and racism arise in politics, media, across EU. Migrant issues part of workers’ claims to rights, but also see rise of reactive nationalisms in sending countries...

PARADOX

Free movement = less movement

Restricted Movement = more and more dangerous movement



# Labour Migrants inside EU

---

‘Post-communist’ countries citizens formerly accepted as refugees during Cold War, later suffered as migrants, and came to be ‘racialized’, with references to numbers, ‘flooding’, crime, diseases and even taking jobs of European beggars!

# Labour Migrants inside EU

---

Somewhat similar that Bulgarians and Romanians post-Cold War in UK especially but also some other countries were:

---

“According to Eurostat data agency 96 per cent of Romanian migrants to EU countries choose destinations other than the UK” !



# Migration and Securitisation

---

Today “we are....told...it is reasonable and acceptable to discriminate for our own good...in the interests of national security...[alongside]...better policies of ‘integration’”

**BUT “...*it is now important to ask what it means to demand that immigrants and minorities integrate into societies that see them as potential threats to their people’s security*”**

# Migrant Workers and Deportation

---

- 2014- 161 309 third-country nationals deported to countries outside EU, similar number in 2013.
- UK the largest number of returns (36 313)
- Greece effected returns 2014, especially Albanians.
- Migrant workers affected as well as failed asylum seekers – the two are not separate except legally and in policy terms (not in reality)

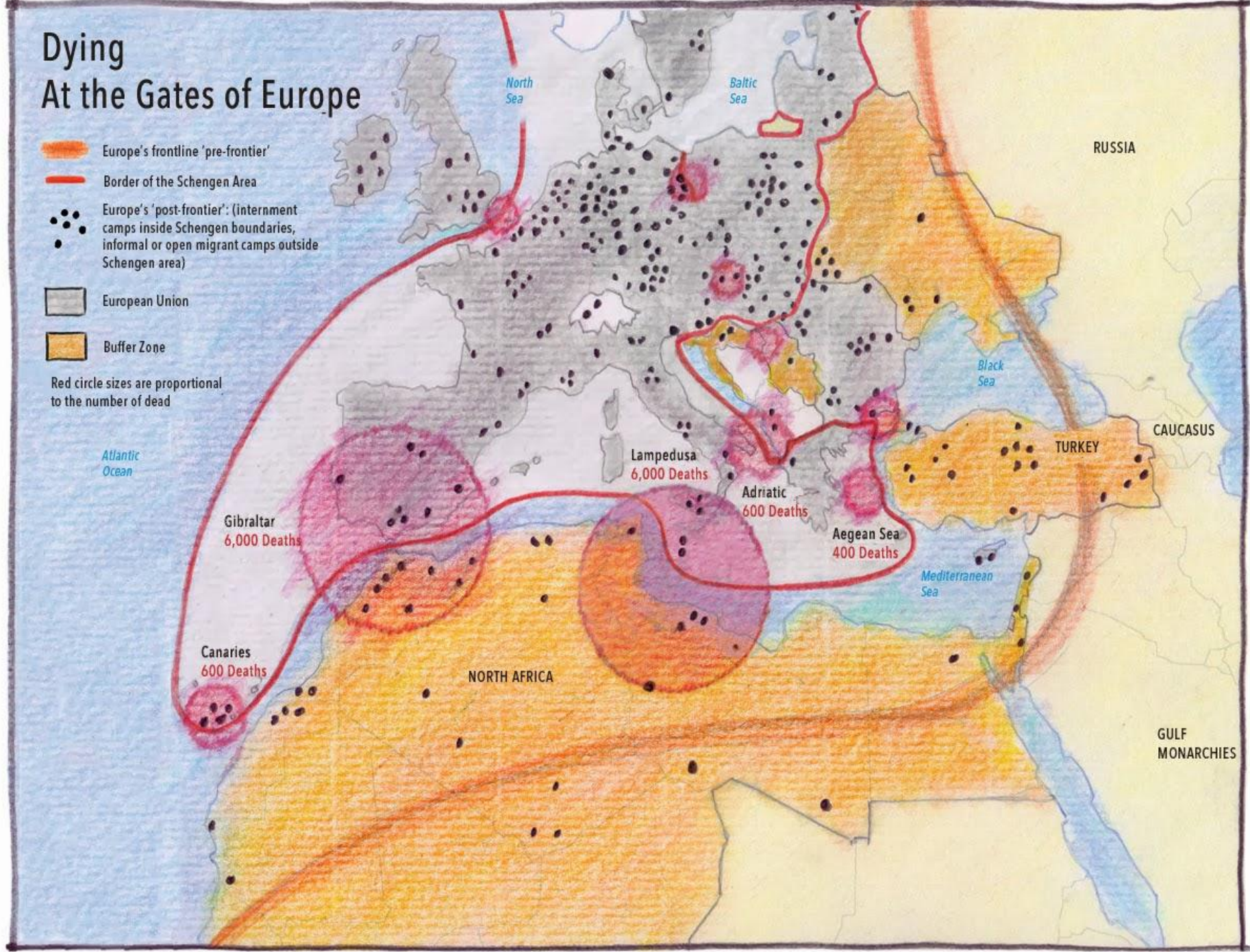

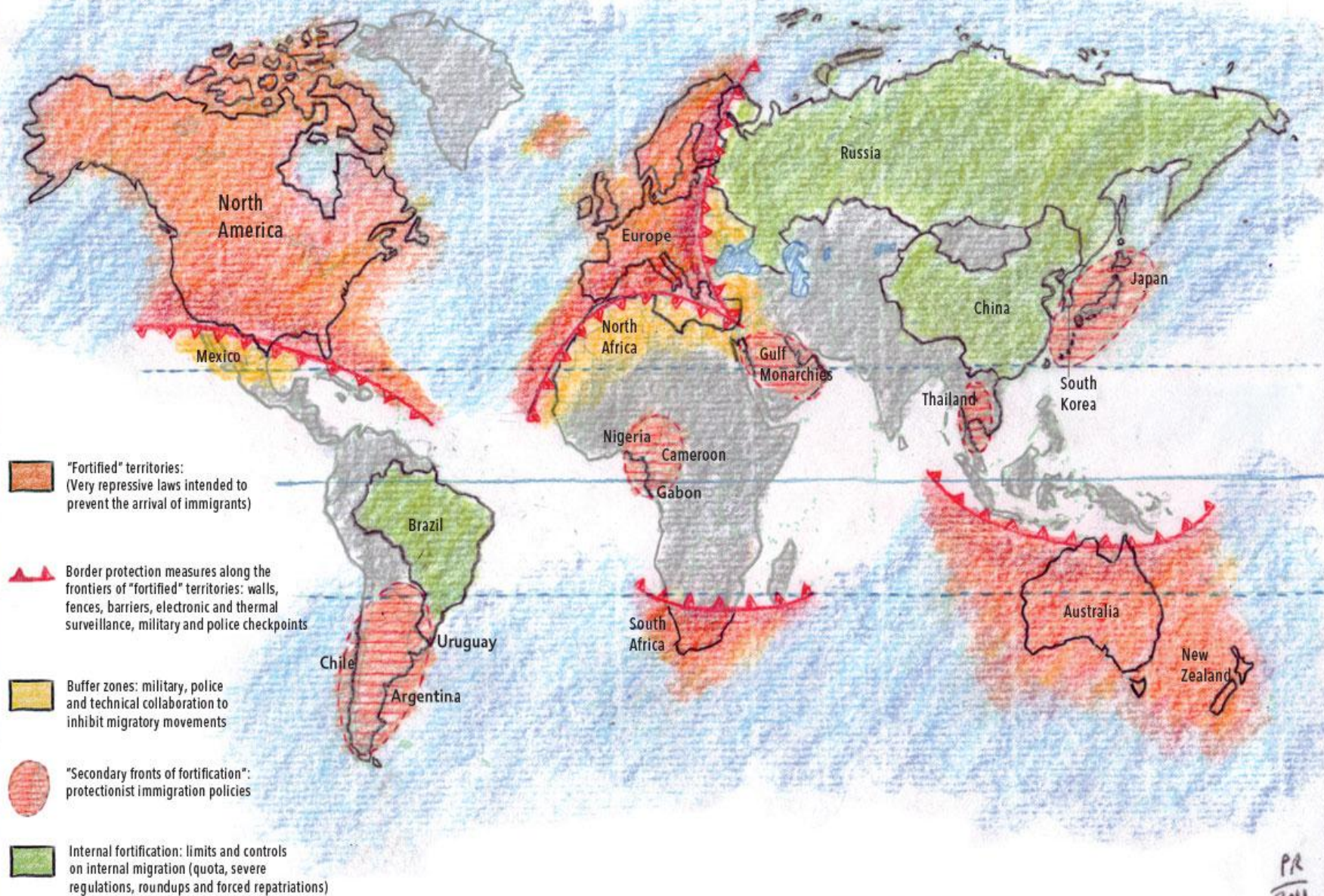
# Migration & Apartheid

---

Like colonial surveillance, today's strategy is to ***screen entire groups of people out of entitlements and benefits, enforcing unequal life chances***, this time in the hope of preventing future cross-border movements...except for those defined as highly skilled expats, desired migrants

Operates inside *and* outside the EU

---

**containment, = those various interventions and technologies that seek to restrict or manage the circulation of incomplete and hence potentially threatening life, or return it from whence it came”.**

# Open *ALL* EU Borders & Allow Work

- = smuggling rackets will no longer make **profits**

---
- = traffickers **less impunity re. undocumented**
- = helps trade unions, lawyers protect workers **rights**
- = migrants can **enter** but also **leave and later return**
  -
- = helps promote **training, work, savings, family life**

# Open *ALL* EU Borders & Allow Work

- = **Non-EU migrants would stop being locked in**
- = across refugees-migrants distinction more **solidarity**
- = more labour **circulatory migration and life-cycle**
- = reduces cost for EU States of **ILO Convention**
- (Migrant Workers and their Families)

**Need global solutions for global problems**
